



2022-23 Immunization Requirements

Commonwealth of Massachusetts and Harvard University regulations require students attending classes on campus who are enrolled full time (16 credits) in the Extension School or on visas of any kind to be immunized against certain communicable diseases. To comply, please have this 2022-2023 Immunization Form completed by your health care provider or medical records official and **submit it by uploading to the Document Uploader available through MyDCE (<https://extension.harvard.edu/login/>)**. Choose “Immunizations” from the drop-down menu.

The only circumstances under which a student may be exempted from these regulations are as follows:

- The student provides written certification by an examining physician that the student’s health would be endangered by one or more of the immunizations. In this case, the student **must** submit laboratory evidence of immunity to measles, mumps, rubella, and varicella (chickenpox); if the student is not immune, the student will be excluded from classes in the event of an outbreak; OR
- The student provides a signed written statement that the required immunizations would conflict with their religious beliefs. It is recommended that he or she present evidence of immunity through laboratory testing as above. Otherwise, the student will be excluded from classes in the event of an outbreak. Please note: parents (including parents of minors) may not submit requests for religious exemptions on behalf of the student. The student must provide a signed statement on their own behalf.

Frequently Asked Questions

What if I don’t submit a complete immunization record before I arrive at Harvard?

We strongly encourage you to receive any required immunizations before you arrive at Harvard, as many health insurance plans will cover the costs of immunizations.

What if I don’t have enough time to complete the full series of the MMR, Hepatitis B, or Varicella vaccinations?

For immunizations requiring more than one inoculation (such as measles, rubella, mumps, hepatitis B, and varicella), you must submit proof that you have begun the series and had as many of the inoculations (shots) as possible within the time frame/schedule specified on the Extension School Immunization Form. In this case, you are considered to be in compliance with the requirements for the current extension term.

My parent/guardian knows the dates I received my shots. Can they sign the form?

All immunization documentation and information must be certified by a health care provider or a medical records official. We cannot accept self-reported immunization information.

What if my doctor does not know the exact date I received the shot or does not have record of it?

Without the full dates of your vaccinations (including month, day, and year), your immunization history does not comply with Massachusetts and Harvard University regulations and your documentation cannot be accepted. If you cannot provide documentation of each required immunization,

there are several of the diseases for which you can have a blood test that will show whether or not you are immune to them (measles, mumps, rubella, hepatitis B, and varicella). You would need to provide the Extension School with the proof of such tests. For the diseases that do not allow blood tests, you must take the immunizations again and provide the proof.

Do I need to complete a whole new form to submit my additional/updated shot information?

If it’s multiple vaccines, you should submit a new form, but should include only the NEW information. Check the box marked, “I have new information to add to the form I submitted earlier this term.” Lastly, the signature of your health care provider or medical records official cannot be earlier than the date of your most recent vaccination in order for your form to be accepted.

How do I know if you have accepted my documentation and completed the requirement?

You may check the status of your immunization certification by visiting the Document Uploader through your MyDCE account. Once your documents have been reviewed, you will see an “Approved Extension” status.

Are COVID-19 vaccinations required?

Yes. If you will have an on-campus presence of **any kind**, Harvard University requires you to submit proof of COVID-19 vaccination (which includes one booster shot if medically eligible).

Where do I submit my COVID-19 vaccinations?

COVID-19 documentation must be uploaded *separately* to the secure Harvard University Health Services (HUHS) Patient Portal (<https://patient.uhs.harvard.edu>). You will need your Harvard Key to upload the document. If you have not claimed your Harvard Key, please visit key.harvard.edu. Please allow 3 days after claiming your Harvard Key before uploading documents to HUHS.

What COVID-19 vaccines are accepted by HUHS?

All vaccines authorized by the FDA or the World Health Organization (WHO) will meet the University’s vaccine requirement. The list of vaccines authorized by WHO is updated regularly.

How can I check the status of my COVID-19 vaccination?

You may check the status of your COVID-19 vaccination by visiting the Patient Portal. Once your documents have been reviewed, you will see the list of required immunizations updated with either a green mark (indicating “compliant”) or a red mark (indicating “not compliant”). All immunizations marked in red require your immediate attention to resolve.

Please submit this form to the Document Uploader available through MyDCE (<https://extension.harvard.edu/login/>) seven days after registration.

Please keep a copy of this form for your own records.
